DURING THE PANDEMIC**

WHAT YOU SHOULD KNOW BEFORE YOU GO



PRIMARY SERIES OF VACCINES

The Center for Disease Control and Prevention (CDC) recommends that everyone 5 years and older receive a primary series of a COVID-19 vaccine to be considered fully vaccinated.

A PRIMARY SERIES CONSISTS OF:

a 2-dose series of an mRNA COVID-19 vaccine (Pfizer-BioNTech or Moderna), or a single-dose COVID-19 vaccine (Johnson & Johnson's Janssen vaccine) or its equivalent according to your country's requirements.

Out of an abundance of caution and to promote the safety of delegates attending national meetings of the Church of Our Lord Jesus Christ, Inc., **delegates 5 years and older attending national meetings are required to be fully vaccinated.**

COOLJC suggests the Booster or its equivalent according to your country's requirements.

Delegates are also required to wear face masks at all times.



CONFERENCE PROTOCOL

INTERNATIONAL CONFERENCE PROTOCOL

Vaccination is mandated for attendance at International Conferences.

Vaccination is defined as the Moderna (both doses), Pfizer (both doses), the Johnson & Johnson, and the Booster for all qualified individuals.

Attendees will be required to present **proof of vaccination.**



PROOF OF VACCINATION

THREE METHODS OF VERIFICATION IS ACCEPTABLE

1. Vaccination card completed.
2. [v-safe.cdc.gov](https://www.cdc.gov/v-safe) on smart device (a pdf is attached with information about the program and how participants can join it)
3. Dated letter from healthcare provider with name of patient, name of vaccine, date(s) of doses received, and the provider's title and signature.

WITH ANY OF THESE, A STANDARD ID CARD WOULD ALSO BE NEEDED.

CONCERN FOR IMMUNITY

Second dose of Moderna or Pfizer **must** have been given at least **two weeks prior to the meeting** and two weeks after Johnson & Johnson vaccine or its equivalent according to your country's requirements.

With respect to COOLJC's effort to protect its attendees from COVID-19, there is **NO EXCEPTION.**

COOLJC is complying with the CDC and Hosting State's regulations.

All approved delegates, attending the COOLJC International meetings, must register and include vaccination information at time of registration.

COMMITMENT TO SAFETY

The Church of Our Lord Jesus Christ (COOLJC) is focused on creating and maintaining a safe experience for everyone. We are complying with the CDC and respective State in which the Conference is held, regulations that require face masks to be worn at all times. **You will not be admitted if you are not properly wearing a face mask.**

YOUR COMMITMENT TO SAFETY (REQUIRED)

- In the past ten days, I have not had a COVID-19 diagnosis.
- I have not experienced the onset of any one of the primary symptoms of COVID-19.
- I have not been in close contact with someone who has COVID-19 in the past ten days.
- I will wear a face mask while attending the events of the respective international conference.

EXCEPTION

- I have been fully vaccinated for at least two weeks or have had COVID-19 within the last 90 days and fully recovered so that I am not contagious, and I remain symptom-free.
